We started by painting our white paper with yellow paint. You could use yellow paper, if you like.

Next we cut out circles from the yellow paper and glued them onto our glass jar.





After we had attached our dots we covered the jar with the blue tissue paper and covered it with the glue and water mix.

While it dried we added some beads to a pipe cleaner.



Then all we had to do was to attach the pipe cleaner to the jar as a handle and insert the candle.
