# **IDEA:** Categories of Disabilities -- Deaf-Blindness

The Individuals with Disabilities Education Act (IDEA) defines **Deaf-Blindness** as:

concomitant hearing and visual impairments, the combination of which causes such severe communication and other developmental and educational needs that they cannot be accommodated in special education programs solely for children with deafness or children with blindness.

### What is Deaf-Blindness?

The term describes a person who has some degree of loss in both vision and hearing. The majority of children who are deaf-blind also have additional physical, medical and/or cognitive problems.

Children are considered to be deaf-blind when the combination of their hearing and vision loss causes such severe communication and other developmental and educational needs that they require significant and unique adaptations in their educational programs.

#### What causes Deaf-Blindness?

Some people are deafblind from birth. Others may be born deaf or hard -of-hearing and become blind or visually impaired later in life; or the reverse may be the case. Others are born with both sight and hearing but may lose some or all of these senses as a result of accident or illness.

About 50 percent of the people in the deaf-blind community have Usher Syndrome. This is a genetic condition where a person is born deaf or hard of hearing, or with a normal hearing, and loses his or her vision later in life from retinitis pigmentosa. Other common causes include birth trauma, optic nerve atrophy, cataracts, glaucoma, or diabetic retinopathy.
