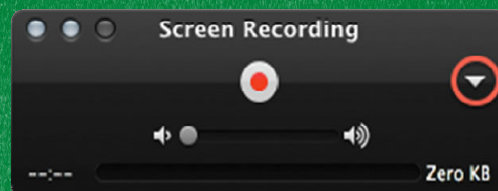

The responsibilities of a state project advisory committee member include:

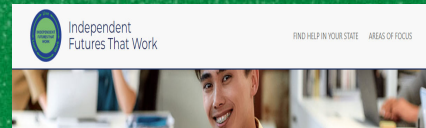
- Attending meetings quarterly

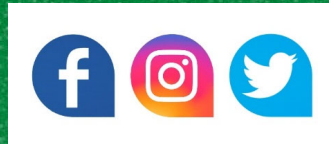

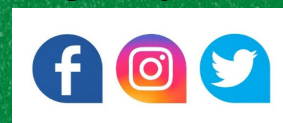
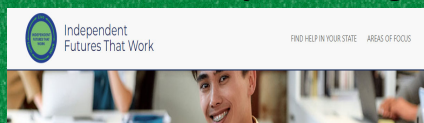
